## THE FEI CODE OF CONDUCT

### FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. **The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.**

## **1. HEALTH REQUIREMENTS FOR THE ENTRY OF HORSES ✓**

**All Horses must be scheduled for arrival. No horse will be unloaded without the approval and consent of the stable manager. Arrival and welcome documents can be found on the official event website: [www.WorldReiningFinal.com](http://www.WorldReiningFinal.com)**

### **From EU countries and from Norway, Andorra and the Faeroe Islands**

#### ***The horses shall be examined by a veterinarian***

Horses that are brought to Sweden shall be examined by an official veterinarian in the country they come from. This examination shall take place within 48 hours before loading the horses into the transport.

The veterinarian must sign a health certificate showing that the animals are healthy according to EU health requirements. This certificate is valid for ten days. During that time, the horses can travel freely between EU countries as well as Norway, Andorra and the Faeroe Islands.

You need to keep the health certificate for six months so that you can show it to an official veterinarian, for instance if there is need to trace a certain disease.

Data on foals younger than six months and travelling with their mother can be stated on the mare's certificate.

#### ***Relaxed health certificate requirements for horses travelling between Nordic countries***

Horses that are to compete in Sweden, Denmark, Finland or Norway do not need a health certificate for travelling between these countries. Horses that are to compete in racing, dressage, show jumping, eventing, endurance, competitions of Icelandic horses, or Western riding, can travel without health certificate for up to five days before the first competition and up to five days after the last day of competition.

When you go to the competition you must be able to show that the horse is to compete, for instance by showing a starting list.

When you return from the competition you must be prepared to show a competition certificate.

If you already have a valid health certificate for the horse you do not need any other documents.

#### ***The horses need passports***

All EU horses older than six months need a horse passport. This is a document of identification that you need to show to the veterinarian who issues the health certificate. You should always bring the horse passport when you are travelling with your horse.

#### ***Import from Norway, Andorra or the Faeroe Islands must be notified***

When you bring horses to Sweden from Norway, Andorra or the Faeroe Islands you need to notify the customs office where you cross the border. Apart from this, the EU rules apply.

### **From non-EU countries except Norway, Andorra and the Faeroe Islands**

Health requirements depend on whether the horses are brought to Sweden to stay, or if it is a temporary import for no more than 90 days, or if a horse is brought back after having been outside the EU for no more than 30 days. Required testing and analyses depend on what diseases are present in the country from which the horse is brought to Sweden.

#### ***The following always applies***

The horses must be examined by an official veterinarian in the country they come from. This examination takes place on the day they are loaded onto their transport vehicle.

The veterinarian must issue a health certificate showing what, if any, tests and analyses need to be made before the horse is brought to Sweden. This certificate is valid for ten days.

You need to keep the health certificate for six months so that you can show it to an official veterinarian, for instance if there is need to trace a certain disease.

***The horses need identification documents***

The horse needs a horse passport or some other approved document of identification that you need to show to the veterinarian who issues the health certificate. If the horse is to remain in Sweden or in some other EU country for more than 90 days, this is considered permanent import. In this case you need to obtain a horse passport after import.

***Enter Sweden through an approved border inspection post***

Horses from non-EU countries except Norway, Andorra and the Faeroe Islands may only be brought to Sweden through an approved border inspection post. Please note that our border inspection posts only accept horses that arrive by airplane. Horses that arrive by ship, for instance from Iceland, need to be taken to a Danish port and enter the EU there.

You need to notify the border inspection veterinarian of the arrival of the horses at least one working day in advance.

If you bring horses from non-EU countries to Sweden via another EU country, you notify entry to the border inspection post where the horses are to enter the EU.

Notify the import to customs when you bring the horses across the border into Sweden.

***Journeys longer than eight hours require a travel plan***

If your planned journey is expected to take more than eight hours, you need to draw up a travel plan. This travel plan needs to be approved by the official veterinarian in the country the horses come from.

**Stall Purchase, Feed and Bedding:**

**Feed services will be provided by Bökeberg Gård. Stall purchase and bedding supplies will be provided exclusively by Bökeberg Gård, with no outside bedding permitted and absolutely no brokering of stalls. Sorry there are no exceptions. - 1) **Parking** – all competitors shall park as directed in the specified parking areas for both automobiles and trailers/vans/lorries
- 2) **Camping** – Recreational Vehicles are allowed, on a first-come, first served basis for a limited number of electric-only spaces. There are also one or two RV locations with clean water. There is a dump site located on-grounds as well. Camping spaces shall be purchased directly from Bökeberg Gård, using the Camping Order form, found at the official event website: [www.WorldReiningFinal.com](http://www.WorldReiningFinal.com)
- 3) **Prize Money** – all winnings will be distributed according to FEI rules within 10 days after the last Competition of the Event. A winnings payment method form can be found at the official event website: [www.WorldReiningFinal.com](http://www.WorldReiningFinal.com) and should be submitted to the Secretariat prior to departure from the event. Payments cannot be made without the information, instructions and approval signature found on this form. If you leave the event without submitting this form, it may cause a delay in payment of your winnings.
- 4) **Protests according to Art 163** - Protests may be lodged by Presidents of NFs, Officials, Chefs d'Equipe or, if a Chef d'Equipe is not present, by a Person Responsible or a Team Veterinarian responsible for horses taking part in the Event, with the exception of protests for abuse which may be lodged by any person or body. An arbitration procedure is provided for under the FEI Statutes, 22nd Edition November 2008 and the FEI General Regulations, 23rd Edition 2009, updates effective 1 January 2011. In accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies must be settled exclusively by the "Court of Arbitration for Sport" (CAS) in Lausanne, Switzerland.
- 5) **Event Organization (Art 109 and 110)** - In exceptional circumstances, together with the approval of the Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the OC may change the schedule in order to clarify any matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the President of the Ground Jury.
- 6) **Cancellation of the Event** If special circumstances demand it, the OC reserves that right to take all necessary actions including the cancellation of the event by repaying the entry fee, with the approval of the FEI.
- 7) **Sponsor Logo (Art 135)** The OC authorizes the athletes to carry the "Logo" of their personal sponsor on their clothing, saddle cloth or carriage (Art 135.2). The Chief Steward is responsible for ensuring that FEI Regulations relating to Art 135 are respected by athletes before entering the arena. Athletes not complying with Art 135 will not be permitted to enter the arena during competition. See also FEI Rules for Reining.

8) **Athletes whose horses leave the venue without permission of the OC during the World Reining Final (from the first horse inspection until after the announcement of the results of the last competition) will be disqualified.**

9) **Stable Security** (Vet Regs Art 1005.2.5)

The following security regulations of the Fire Department must be obeyed:

- ✓ Smoking is strictly prohibited in the entire stable area.
- ✓ Open fires (e.g. camping stoves) are strictly prohibited.
- ✓ Only the actually needed amount of feed supplies may be stored in the stables.
- ✓ Open space and entry ways between the stables may not be obstructed by trucks or vans.
- ✓ All electrical plugs must meet safety standards.

***Those who disregard the above security regulations will incur a fine levied by the OC.***

10) **Competitors in the World Reining Final** are required to participate in the Opening Ceremonies, Press Events (which shall be scheduled in advance), including press conferences and autograph signing sessions as well as other sport-promoting activities. These responsibilities are requisite and by making entry into the competition, you agree to participate and represent your sport of Reining to the highest possible standard.

11) Competitors understand and acknowledge that the sport will be presented in a **high-production and crowd-pleasing atmosphere**. Especially the higher level competitions shall have a level of crowd participation, music and announcement that is expected of an international sporting event. Competitors are encouraged to prepare for this environment and it is expected that you and your horses are well suited for your surroundings in the event. By entering this competition, you acknowledge that you are aware of this enhanced production level and prepared to compete within its framework.

12) **Numbers – Bridle numbers**, which correspond to the horse will be issued upon arrival, or upon passport control/vet examination and horse identification. Once the horse has been identified, bridle numbers must be worn at all times when a horse is out of the stall and always under the supervision of the steward's commission. Competition Numbers will be issued by the Secretariat, which shall be worn instead of bridle numbers on the side of the saddle pad, facing the president of the ground jury (chairs 1, 2 & 3).
